## **RELEASE AND INDEMNIFICATION**

THE UNDERSIGNED, (WHETHER ONE OR MORE, THE "PARTICIPANT"), in consideration of admittance to the Event as requested by ACTION MASTERS PISTOL CLUB, Inc., on behalf of Participant, participant's heirs, legal representatives, and assigns, agrees to and hereby does release ACTION MASTERS PISTOL CLUB, Inc. (hereinafter respectively and collectively referred to as "Members") from, and jointly and severally agrees to indemnify and hold each of Members harmless from and against, any and all liabilities, cost and expenses (including reasonable attorney's fees and expenses of litigation) which they may jointly or severally incur to the Participant, their heirs, legal representatives or assigns, in respect of any claim, suit, or cause of action of whatever kind or nature arising from, related to or on account of any Participant's presence at or participation in the Event, including, without limitation, any such injury, loss of damage resulting from any failure to perform on the part of any person with whom Members have contracted for goods and services in connection with the Event, any civil commotion, force majeure, acts of God or government, or otherwise; and the Participant further agrees to and hereby does release Members from and jointly and severally agrees to indemnify and hold each of Members harmless from and against, any and all liabilities, costs expenses (including reasonable attorney's fees and expenses of litigations) which they may jointly or severally incur to any person, claim, suit, or cause of action of whatever kind or nature on account of any personal injury, loss of health, financial loss or damage to a property, directly or indirectly sustained by such person, their heirs, legal representatives or assigns, as a result of the Participant's action, series of actions, or failure to act in or in connection with the Event or otherwise. This indemnification shall also be valid for participants under the age of 21 when signed by a parent, guardian, or other caretaker of such Participant(s). Participant will obey all applicable laws, written and oral rules, direction, practices and procedures whether with respect to safety, conduct or otherwise; and in recognition of the danger to which participant is voluntarily subjected in connection with the Event hereby knowingly, freely and voluntarily assumes the risks and waives any rights or cause of action, of any kind whatsoever, arising out of or as a result of such Event or such activity and/or participation from which any liability may or could accrue to Members and covenants never to sue Members on accounts thereof. Participant acknowledges and agrees that no alcoholic beverages or drugs are permitted at the Event, Participant has not imbibed any alcoholic beverages of any manner whatsoever; that participant is experienced with the risk and safety rules of shooting sports; that all guns must be left unloaded, breached or open except when participant is in a safe position in a shooting stand/box; and that safety eye and ear protection will be worn by Participant at all times at the Event.
